# **Boys-to-Men Mentoring Network, Arizona**

## **Criminal History and Background Checks**

Boys-to-Men Rite of Passage weekend staff and mentors that work with boys in follow up meetings must have no past history of sexual abuse of children, no convictions for any crime in which children were involved, and no history of any violence or sexually exploitative behavior, and no felony convictions within the last five years. If you have such a history, you may not serve as staff to the weekend, or as a mentor. For those with such histories, Boys-to-Men offers other volunteer opportunities that do not involve direct contact with boys.

Boys-to-Men requests information regarding any prior felony convictions. Additionally, background checks are required for all staff and mentors. This information is made available to the staff selection committee. In some cases, if a man has a criminal history but is still selected to staff a weekend, the information may be disclosed to the leaders of the weekend. This information is kept in confidence and all copies are destroyed following staff selection.

## **Background Questions**
